As a transitional economy on the path to European Union integration, North Macedonia faces structural

challenges that delay its ability to foster and sustain innovation. One of the core objectives of the

Sustainable Development Goals (SDGs) is to strengthen national capacities for innovation and research

and development (R&D), essential for transforming economies into knowledge-based systems and

ensuring sustainable, inclusive growth.

This paper examines the relationship between the Global Innovation Index (GII) and North Macedonia's

economic performance, evaluating how innovation-related policies and practices have influenced

macroeconomic indicators over the past decade. Focusing on key GII pillars—human capital and

research, infrastructure, market sophistication, and knowledge and technology outputs—the study

correlates these with GDP growth, foreign direct investment (FDI), and employment rates.

Findings suggest that while North Macedonia has made notable progress in digital infrastructure and

entrepreneurship support, innovation inputs often exceed outputs, close-fitting a gap between investment

and implementation.

The study highlights the need for a cohesive national innovation strategy, stronger institutional

State Aid Recovery and MGA Risk: Navigating Successor Liability in Light of ECJ Case C-

588/23

**Abstract** 

The judgment of the European Court of Justice in Case C-588/23, delivered on 16 January 2025, represents a

notable development in the jurisprudence surrounding the recovery of unlawful State aid. Central to the Court's

reasoning is the reaffirmation of the principle that repayment obligations may, under certain conditions, extend

beyond the original beneficiary to a successor undertaking. This is particularly relevant where core elements of

the business—such as assets, workforce, and operational continuity— have been transferred in substance,

even if not in form.

This paper situates the ruling within the broader legal framework of economic continuity, examining how the

Court has built on prior case law, including Germany v.

Commission (C-277/00), Groupe Lactalis v. Commission (T-121/15), and Ryanair v. Commission (T-123/09),

to clarify the circumstances under which successors may be held liable. By analyzing the factual and legal tests

applied—such as the preservation of economic activity, overlap in ownership or control, and transactional

context—the study highlights the implications of the judgment for merger structuring, insolvency procedures,

and public enforcement of competition rules.

The findings underscore the strategic importance of assessing legacy State aid exposure in the context of

corporate acquisitions and reorganizations, particularly where distressed assets or privatizations are involved.

This paper aims to contribute to a more practical understanding of successor liability and its impact on

transactional risk within the internal market.

Empirical Analysis On The Effects Of Flat Tax Reform On Fiscal Revenues And **Economic Performance For The Case Of Republic Of North Macedonia**

**Abstract** 

A well-structured tax system created by a sound tax policy and appropriate tax reforms is vital for a

country's economy. An efficient tax system enables economic stability, social equity and sustainable

development. Likewise, tax policy is essential and has a major impact on investment decisions, tax

revenue collection and fiscal stability, whereas tax reforms are undertaken by the governments to support

these objectives and adapt fiscal policies to changing economic conditions, improve the tax administration

as well as reduce tax evasion. Thus, the main purpose of this study is to provide a comprehensive

empirical analysis of the role of flat tax reform on tax revenue generation and economic performance of

Republic of North Macedonia from 2000 – 2023 period. An econometric assessment is conducted based

on Error Correction Method (ECM) to capture both, short run and long run relationships. The results

imply that the tax reform from progressive to flat tax rate has positively affected the tax collection over

the long run. Also, it was found a positive and significant relationship between real GDP and tax

revenues, whereas not significant relationship between government budget balance and tax revenues,

reflecting fiscal stability concerns.

## Exploring the role of female education and youth unemployment on GDP:Case of North Macedonia

#### Abstract

This paper explores the effects of female education attainment, youth unemployment, and economic growth in North Macedonia. Using regression analysis model, this study analyzes the effects of secondary and tertiary school enrollment rates, as well as female youth unemployment on the economic growth. The analysis uses data from World Bank ,covering the period from 2000 to 2023. The results suggest that tertiary education has a significant positive effect on economic growth, while higher youth unemployment among females is expected to harm economic growth. Based on these findings, the study proposes measures and policy recommendations aimed at reducing female youth unemployment and increasing access to tertiary education to achieve higher economic growth.

#### Growth Without Equity: Evidence of Non-Inclusive Economic Growth in the Balkans

#### **Abstract**

Facing ever-evolving economic insecurities that endanger the economic well-being of the whole world and focusing on what those implications mean for the Balkans, this paper aims to investigate the relationship between economic growth and poverty in this geographic region. The paper covers the period from 2006 to 2021 for the following countries: Albania, Bulgaria, Greece, Croatia, North Macedonia, Montenegro, Romania, Serbia, Slovenia, and Kosovo. The research explores whether economic growth in the region has been inclusive by estimating bidirectional panel regression models. The results show that GDP growth is associated with rising poverty. In the control model, when the variables' position is swapped, poverty seems to be also associated with rising economic growth. To test the directional predictive power, the Granger test was introduced. The results from the Granger causality test show that the trend in economic growth truly predicts the trend of poverty, while poverty does not Granger-cause GDP, suggesting that the relationship is unidirectional. The findings suggest the occurrence of non-inclusive growth in the Balkans, benefiting limited groups in society while leaving the poor on the margins of society. This type of growth indicates the exploitation of resources and labor, while state redistribution efforts fail to correct those market imperfections toward a more equal society. As this is expected to persist or exacerbate as we are at the brink of AI-driven transformation of markets and society, states must finally recognize the need for people- centered policies – such as reforms of the social protection systems, tax reforms, and rethink the growth models in post-transition economies.

#### Abstract

The traditional classroom model has undergone significant changes with the advent of ICT. The way that students feel about using ICT in the classroom has a big impact on their overall EFL performance. Numerous studies on attitudes toward information and communication technologies (ICT) have been conducted regarding students' attitudes towards ICT. The attitudes of Prishtina high school EFL students toward ICTs have been the subject of relatively little investigation. This study sought to ascertain the attitudes of Prishtina high school EFL students regarding information and communication technologies in the EFL classroom, in keeping with the current trend of encouraging a wider use of ICT in EFL classrooms in Prishtina. Work: A Comparative Analysis of V4 Countries, Ukraine, and North Macedonia

**Abstract** 

Inclusive education is a concept and way of life that modern society is striving to embrace, although some

countries are more successful in this effort than others. For this purpose, as part of the Visegrad+ project

"Towards Inclusive Practices and Positive Behavior Support in Education and Social Work," research was

conducted among the Visegrad (V4) countries, Ukraine, and North Macedonia. The study aimed to

investigate the best practice in inclusive education through desktop analysis and interviews with

specialists in inclusive education, with a special emphasis on the use of applied behavior analysis (ABA).

The results show that all these countries have adopted legislation regarding inclusion in primary

education, though with limited implementation, and all of them offer studies at universities for specialists

in inclusive education. In the V4 countries, a significant progress in establishing legal frameworks for

ABA education and the profession of behavior analysts has been observed. However the same does not

apply for North Macedonia, where the lacking legal framework has been limiting the quality and

availability of behavioral support in inclusive education.

The research also confirmed the expected negative impact of the war in Ukraine on the education of

behavior analysts. Interviews with professionals working in inclusive schools were a complementary part

of the research methodology, highlighting the lack of accessibility to ABA education and the need to

develop behavioral skills to address the challenging behavior of students.

This report identified gaps and needs in inclusive education implementing ABA, leading to the creation of

an online training curriculum for school professionals.

Transition to the green economy for the Western Balkans is both challenging and full of promise, considering the countries in the region's circumstance with fossil fuel dependence, ineffective regulation, and lack of investment in green infrastructure. Given the Western Balkans' predicament with regard to fossil fuel dependence, inefficient regulation, and a lack of investment in green infrastructure, the region's transition to a green economy is both challenging and full of promise. But increased policy alignment with the European Union (EU) and greening of the financial mechanisms offers the path towards sustainable economic growth. The study examines the connection between carbon emissions, environmental policies, and economic growth in six Western Balkan nations using an econometric panel data technique, fixed-effects, and random-effects estimation. Macroeconomic and environmental variables derived from World Bank Indicators are included in the data set, which spans the years 2000-2024. The models take into account how GDP, green legislation, and green foreign direct investment (FDI) affects both GDP growth and carbon emissions reduction. The Hausman test is used to determine the model selection. The evidence indicates that investments in renewable energy and green policy have a very strong negative effect on carbon emissions, while subsidies for fossil fuels continue to slow down efforts. The analysis further indicates the beneficial effect of EU-driven reforms on the acceleration of the green transition. With these findings in mind, the research presents significant policy recommendations, from phasing out the subsidization of fossil fuels to a surge in green financial instruments, and enhancing regulation enforcement mechanisms. These measures will make it possible for the Western Balkans to embrace a greener economic trajectory while being aligned with the EU climate policy targets.

# Barriers to Independent Living for Young Adults with High-Functioning Autism in Europe

#### **Abstract**

High-functioning autism refers to individuals with average or above-average intelligence who may face social, communication, executive functioning and sensory processing challenges.

People with high-functioning autism in Europe face significant barriers transitioning to independent living, as identified by the Erasmus+ project "Houses4Autism". Key challenges include mental health issues, poor financial literacy, sensory overload, and difficulties sharing spaces and responsibilities (Baldwin and Costley, 2016)

This article presents our study conducted across Cyprus, Denmark, Ireland, Italy and the Republic of North Macedonia as part of the Houses4Autism project (Nov. 2023-April 2024). We combined a literature review and an analysis of good practices that supported independent living among individuals with high-functioning autism with accessible surveys engaging directly with individuals with high-functioning autism and their families/caregivers. Combining primary and secondary research activities into an academic article comprehensively outlined the barriers these individuals face when attempting to live independently. Through this activity, we identified that the greatest barrier to their independent living was a lack of an accessible support system or opportunities that could empower, support and sustain their independent living. Such a support system, according to this research, should include support/training in: navigating complex public and social services required for independent living (healthcare system, financial services, etc.); managing stress, anxiety and mental health issues; managing finances; managing everyday home activities (cooking healthily, cleaning, household chores, etc.); enhancing and increasing social interactions through the development of social skills; organisational skills training; and understanding sensory issues/overload and how to manage and cope with these.

**Abstract** 

Objective: This study aimed to determine the effects of obstetric violence on birth stress and fear

experienced by women in labor.

Methods: The literature search was conducted by examining Google Scholar, Cochrane, Pubmed, Web of

Science, Science Direct, Medline databases. Studies conducted between 2015-2024 were included in the

study. The keywords in Turkish were determined as "obstetric violence", "birth", "fear of birth",

"midwifery" and "stress". In English; "obstetric violence", "birth", "delivery", "labor", "fear of birth",

"midwifery" and "stress".

Results: Women who do not receive respectful care during childbirth may be more vulnerable to negative

encounters within the health system. Such negative encounters can lead to a lack of trust in healthcare

professionals, stress and fear of childbirth, and may lead women to avoid medical intervention altogether

or avoid becoming pregnant. It has been concluded that women with reduced fear of childbirth have

decreased labor pain, birth complications, labor duration, traumatic stress disorder, cesarean section rate,

neonatal complications, postpartum psychological problems, strengthened mother-baby relationship and

breastfeeding is positively affected.

Conclusion and Recommendations: This review showed that there can be serious consequences for

women who experience obstetric violence, including fear of giving birth in the future, post-traumatic

stress disorder (PTSD), anxiety and depression. The experience of traumatic birth may lead women to

choose elective caesarean section (CS) for future births, potentially contributing to the high rate of CS

worldwide. This topic can be included in training to prevent obstetric violence and improve the

relationship between women and health professionals. Additionally, studies can be conducted to

strengthen the counseling and communication skills of health professionals. It is thought that conducting

various studies on the causes of obstetric violence and its role in fear of birth can guide the development

of various application policies to prevent obstetric violence.

Abstract

This study explores the usability of an Artificial Intelligence (AI)-supported Learning Management

System (LMS) implemented at Erzincan Binali Yıldırım University (EBYU), the first of its kind in

Turkey. The research focuses on how students perceive the system's usability, particularly in relation to

demographic factors such as gender, age, and frequency of use. Utilizing the System Usability Scale

(SUS), data were collected from 82 undergraduate students who had actively used the AI-enhanced

features of the LMS for at least one semester. Findings indicate an above-average usability score (M =

75.2), with significant differences observed across gender and age groups. Female and younger students

reported higher satisfaction levels, and more frequent use of the system correlated with greater perceived

usability. These results suggest that EBYU's AI-supported LMS is both effective and user-friendly. The

study highlights the importance of personalized training and technical support to maximize the benefits of

AI integration in higher education environments.

Carbon Hysteresis in Turkey: Implications for Environmental Policies

**Abstract** 

This study aims to examine whether the carbon hysteresis hypothesis is valid in Turkey. As a significant

global carbon emitter, Turkey has been developing policies to reduce carbon emissions and enhance

environmental sustainability. In this context, the study analyzes the long-term behavior of carbon

emissions and the presence of hysteresis using annual data from 1999 to 2023. The presence of carbon

hysteresis was first examined using ADF and PP unit root tests to determine whether the series was

stationary. The findings indicate that carbon emissions are not stationary at the level but become

stationary after taking the first difference. This suggests that the carbon hysteresis hypothesis may be

valid. However, since conventional unit root tests do not account for structural breaks, Lee and Strazicich

(2013) single-break and Lee and Strazicich (2003) two-break unit root tests were applied to provide a

more accurate analysis of the long-term dynamics of the series. The results reveal that the carbon

emissions series exhibited structural breaks in 2005 and 2019. These breaks are associated with changes

in Turkey's environmental regulations, global economic fluctuations, and shifts in environmental policies.

According to the analysis, when structural breaks are considered, the carbon emissions series contains a

unit root, confirming that the carbon hysteresis hypothesis is valid for Turkey. This finding indicates that

shocks to carbon emissions have long-term persistent effects and that emissions do not naturally return to

lower levels.

### Is Unemployment Hysteria Valid in Turkey? Empirical Evidence from Unit Root Tests with Structural Breaks

### Hakan EYGU<sup>63</sup>

### Abstract

The primary objective of this study is to assess the validity of the unemployment hysteresis hypothesis in Turkey and provide empirical evidence. Annual data on the unemployment rate for individuals aged 15 and over in Turkey from 1999 to 2023 are utilized. If the unemployment hysteresis hypothesis holds, a shock affecting the series is expected to have a lasting impact in the long run. To investigate the stationarity of the series, structural break unit root tests have been applied. The widely used Lagrange Multiplier (LM) type single-break test by Lee and Strazicich (2013) and the two-break test by Lee and Strazicich (2003) are employed. The identified break dates correspond to the 2001 and 2008 financial crises, which significantly disrupted Turkey's macroeconomic stability. The test results indicate that the unemployment series is stationary, with shocks having no permanent impact. Consequently, over the examined period, unemployment hysteresis is found to be invalid in Turkey, and economic shocks are shown to have only temporary effects on unemployment rates.

# Is the Feldstein-Horioka Puzzle Valid in BRICS-T Countries? An Empirical Investigation on Capital Mobility

### Mehmet AYDIN<sup>66</sup>

### **Abstract**

The relationship between savings and investment plays a crucial role in shaping sustainable economic growth strategies of countries. The Feldstein-Horioka (1980) puzzle posits that the strength of this relationship depends on the degree of capital mobility across borders. According to this hypothesis, in economies with restricted capital flows, a strong correlation exists between domestic savings and investment, whereas in economies with high capital mobility, the relationship tends to weaken or disappear altogether. This study empirically investigates the Feldstein-Horioka hypothesis for BRICS-T countries (Brazil, Russia, India, China, South Africa, and Turkey) over the period 1989–2023 using panel data analysis methods. The empirical findings indicate that in all countries examined, domestic savings have a statistically significant and positive effect on investment. The findings of the panel confirm the presence of a long-term relationship between savings and investment across BRICS-T countries and reveal that approximately 69% of investments are financed by domestic savings. These results suggest that investments in BRICS-T countries are still largely reliant on domestic savings, underscoring the importance of policies aimed at increasing national saving rates to ensure sustainable economic growth. In this context, measures such as tax incentives for household savings, the promotion of financial literacy, and the diversification of saving instruments are recommended. Furthermore, deepening capital markets and improving the investment climate to attract more foreign direct and portfolio investment are identified as complementary policy areas for supporting long-run growth.

Revisiting the Role of Foreign Aid and Government Expenditure in Economic Growth:

Evidence from EAC Countries through a Theoretical Perspective

Abstract

This study investigates the long-run effects of foreign aid and government expenditure on economic

growth in East African Community (EAC) countries. The theoretical framework is grounded in classical

development models. The Harrod-Domar model suggests that economic growth depends on investment,

which can be financed through government expenditure or external assistance. Similarly, the Keynesian

approach argues that government expenditure if directed toward productive sectors can stimulate

aggregate demand and drive economic expansion. Additionally, the Two-Gap model emphasizes that

foreign aid can help developing countries close savings and foreign exchange gaps, enabling necessary

public investments for growth. Based on this theoretical background, this study analyzes the effects of

foreign aid and government expenditure on economic growth in the EAC between 2000 and 2021 using

the Dynamic Common Correlated Effects (DCCE) estimator. The findings show that foreign aid has a

positive effect on growth in Kenya, Uganda, and the EAC panel overall. Government expenditure,

however, negatively impacts growth in Uganda and Tanzania but positively in Kenya. These results may

reflect country-specific fiscal conditions. In Uganda and Tanzania, high recurrent expenditure limits the

growth impact of government expenditure, as both countries face challenges in public financial

management. In contrast, Kenya has focused on infrastructure investment, driving growth. The positive

effect of foreign aid in Kenya and Uganda may stem from better aid coordination and stronger

institutional capacity. Given the positive impact of foreign aid in the EAC panel, countries should

prioritize improving aid management to ensure efficient allocation and foster sustainable growth.

Is Growth Greener Yet in Turkiye?

**Abstract** 

This study investigates the nexus between economic growth, and energy consumption in Türkiye utilizing

the Autoregressive Distributed Lag (ARDL) approach. The variables were transformed into logarithmic

form. The stationarity of the variables was confirmed using ADF and PP unit root tests, indicating that all

series became stationary at first difference. The optimal lag length was determined as four based on all

information criteria. Moreover, the bounds test confirms the existence of a long-run cointegration

relationship among the analyzed variables. Furthermore, for model precision verification, we performed

diagnostic assessments, namely, the Breusch-Godfrey serial correlation LM, the ARCH test, the Ramsey

RESET, and CUSUM and CUSUM of squares, which demonstrated the stability of the dataset. Both GDP

and energy consumption have a statistically significant positive effect on the ecological footprint in the

short run, with energy consumption exerting the strongest impact. However, the long-run coefficients

reveal that GDP does not exhibit a significant long-term effect, while energy consumption positively

influences ecological degradation, underlining the pressing environmental costs of energy use in Turkiye

and highlighting the importance of sustainable energy policy and environmental regulation in achieving

ecological balance.

Party-related factors are examined through the party's program, its position in politics, its establishment date and temporal development. The factors listed are selected among the most discussed factors in the literature and each factor is analyzed in depth and supported by academic studies. The aim of this study is to bring together the factors affecting voting behavior of voters and to make sense of voter behavior. Voters' participation in voting changes national and international balances. Therefore, by identifying the factors that influence voters in the voting process and internalizing these factors, it is aimed to achieve a better position socially, politically and socially through voters, candidates and party members. Driven by advancements in digital technologies, the digital platform economy currently is emerging as a transformative force in the global economic landscape, generating around USD 14.105 trillion in the regiones of America, Europa, Asia-Pacific and Africa in 2023. The gig economy, as its vital component, leverages digital platforms to offer flexible work opportunities and work arrangements, where the platform workers engaged in non-traditional modes of employment, such as freelancers, gig workers, independent contractors, and project-based workers, rely heavily on digital platforms to find and manage their work. Within this evolving ecosystem, the gig economy has gained prominence for offering flexibility and psychological autonomy. Additionally, the global reach of digital platforms breaks down geographical barriers, enabling its workers to access opportunities worldwide. However, platform workers often face job insecurity and lack traditional employment benefits such as health insurance and retirement plans. Furthermore, the continuous advancements in technology require them to regularly update their skills to remain competitive, which reinforces the unpredictable nature of this work arrangement and could lead to stress and burnout. # Pedagogical Aspects of Podcasts in EFL Classrooms: A Qualitative Analysis of Teachers' Perceptions and Attitudes

### **Abstract**

The integration of Information and Communication Technology (ICT) tools within educational environments has gained significant attention in recent decades. In particular, English as a Foreign Language (EFL) classrooms have recognized the importance of leveraging digital learning and teaching tools for their potential to enhance interactivity and learning outcomes. Among these tools, podcasts have proven highly effective in facilitating advanced language acquisition by improving listening comprehension and speaking skills and promoting autonomous learning. However, despite these advantages, the integration of podcasts into formal educational settings is notably inconsistent, specifically in developing regions like North Macedonia. Even though the country's National ICT Strategy aims at improving digital skills and digitizing the infrastructure, effective integration of digital learning tools like podcasts is crucial to realizing these objectives. This paper critically examines the role of podcasts in formal settings of EFL instruction by exploring the perceptions and attitudes of teachers towards their effectiveness. Accordingly, a qualitative approach is employed, combining credible secondary research with data from publicly available podcasts/interviews with experts. Using thematic analysis, the study identifies that podcasts enable teachers to provide authentic language exposure and foster autonomous learning, leading to improved language learning outcomes as compared to traditional methods. While their inconsistent adoption is largely due to technological constraints, insufficient teachers' training and inadequate curricular support, this study highlights that teachers view podcasts as highly adaptable and easy to integrate, even in resource-constrained settings, making them an effective tool for EFL context. Consequently, this research contributes to the existing literature on digital pedagogy, offering specific recommendations for integrating podcast-based learning into North Macedonia's educational system, and thus, supporting the successful implementation of its National ICT Strategy.

The National Accreditation Commission (CNA) oversees an institutional accreditation system that

requires compliance with various academic and financial indicators. At the same time, the National

Agency for Research and Development (ANID) offers funding opportunities for researchers and

graduates, allowing the realization of projects that generate doctoral theses, articles, and patents within

disciplines defined by the Government and the relevant academic bodies of the country. Accreditation,

granted for a maximum of seven years, is considered a direct indicator of academic excellence, and non-

accredited institutions may be excluded from the higher education system, affecting teachers, students,

and administrative staff.

To meet these requirements, universities have had to establish an evaluation framework to measure the

capacity of their members, especially in generating original research and academic publications.

However, this approach has led to sustained growth in the number of scientific publications, albeit with

adverse effects. Limited resources and the obligation to publish in greater numbers have led to problems

affecting the quality of research and to harmful phenomena, such as the increase in the retraction of

scientific articles or the proliferation of so-called predatory scientific journals driven by commercial

interests rather than academic rigor.

analyzes the current criteria of academic evaluation in Chile, highlighting the excessive reliance on

metrics such as impact factor, quartiles and the number of publications in Web of Science (WOS) and

This study investigates the influence of behavioral biases, particularly overconfidence, herding behavior,

and loss aversion, on risk perception and decision-making in Takaful operations. As a Shariah-compliant

alternative to conventional insurance, Takaful is founded on principles of cooperation and ethical risk-

sharing. However, despite these religious and ethical foundations, cognitive limitations among

stakeholders may distort judgment and compromise optimal decision outcomes. Drawing on behavioral

finance theories, particularly Prospect Theory, this research employs a mixed-methods approach that

combines a cross-sectional survey of 312 Takaful stakeholders across Malaysia, Indonesia, and selected

GCC countries with expert interviews to provide qualitative insights. Structural Equation Modeling

(SEM) is utilized to examine direct and indirect effects among constructs. The findings reveal that all

three behavioral biases significantly impact decision-making, with risk perception acting as a mediating

variable. Specifically, overconfidence reduces risk sensitivity, herding behavior fosters non-rational

conformity, and loss aversion discourages participation in investment-linked Takaful products. These

results highlight the importance of integrating behavioral risk management into the operational,

regulatory, and communication strategies of Takaful institutions. This study contributes to the Islamic

finance literature by contextualizing behavioral biases within a Shariah-compliant framework and

advancing the theoretical understanding of risk perception in ethical finance. Practical recommendations

include behavioral literacy training, simplification of product disclosures, and the development of

enhanced regulatory frameworks. The study also suggests future research avenues in longitudinal and

cross-cultural behavioral analysis within Islamic insurance systems.

Human Resources has no effect on Managerial Performance, furthermore Information Technology has no effect on

Managerial Performance, and the Management Accounting System has a positive effect on Managerial

Performance. For the moderating effect of Environmental Uncertainty there is no influence on the Quality of

Human Resources, Information Technology, and Management Accounting Systems on Managerial Performance.

**Abstract** 

In post-communist Romania, the deinstitutionalization process for adults with disabilities has faced

significant challenges despite successive reforms in the social services sector. This study analyzes the

accelerated public policy of deinstitutionalization, initiated as a result of international commitments made

by the government and subsequently transposed into national legislation. Although these reforms aimed

primarily at community integration for individuals in residential care, over three decades later, the number

of institutionalized beneficiaries remains high. This indicates systemic difficulties in transferring services

from the county level to the local level, as well as in reconfiguring adequate community support.

Deinstitutionalization is a complex process, impacting not only the direct beneficiaries but also the staff

of residential centers and community social services.

The study employs a qualitative methodology based on information gathered from three focus groups,

with participants being specialists from county and local social services. The analysis seeks to capture

their perceptions regarding the challenges and opportunities posed by this accelerated public policy, with

a focus on ways to expedite reforms and ensure a sustainable transition. The study's conclusions highlight

the need to strengthen community infrastructure and develop a support network tailored to beneficiaries'

needs to ensure the success of the deinstitutionalization process.

**Abstract** 

This study examines the historical development and production processes of the local dessert of Kocaeli,

Pismaniye. Sectoral development and especially the need for labor skills have been analyzed. The effect of the

transition of Pismaniye from traditional production methods to industrial production on the quality of the labor

force in the sector and the labor skill gap have been revealed. The supply of qualified labor force and the skill gap

in the labor market are gaining importance as increasing problems in the Pişmaniye sector as in different sectors.

The research was conducted in the "Buşah Pişmaniye" enterprise operating in İzmit. The research model was

created as an exploratory one. Qualitative research methods were used in the research and a semi-structured

interview form was used as the data collection tool.

The research was conducted on 38 employees in the enterprise. Face-to-face interviews lasting 30 minutes were

conducted with each employee.

The following findings were obtained in the research; Pişmaniye production is a traditional craft that requires

manual labor and mastery. The education and skill level of the labor force is low. There is a lack of qualified labor

force and insufficient skills in the sector. There are relatively low wages and difficult working conditions. The

perception of profession and professionalization of employees is low. The results of the study offer the following

suggestions for the sustainability and competitiveness of the phyllo pastry sector: Integrating developing

technology into the production process along with traditional production methods. Investing in R&D activities to

develop new products that meet consumer demands. Consumer preferences are diversifying from traditional phyllo

pastry varieties to gluten-free and differently flavored products. In this context, research on consumer preferences is

needed. Strengthening the promotion of the sector and increasing export potential. For the development of the

sector, vocational training programs need to be published, R&D investments need to be increased and promotional

activities need to be strengthened. Developing innovative methods in vocational training, implementing the

learning outcomes approach and quality assurance. Implementing new working models for changing technology

and working conditions.

This article examines the interaction between smart contracts and international private law, focusing on

challenges related to the determination of applicable law, jurisdiction, and recognition of automated

obligations. Methodologically, the research adopts a comparative approach, analyzing European Union

regulations, the UNIDROIT Principles, and selected national legislative initiatives. The findings reveal a

lack of uniformity in the treatment of smart contracts, generating uncertainty in areas such as consumer

protection, contractual autonomy, and dispute resolution. At the same time, international legal instruments

demonstrate an increasing tendency to accommodate technological innovations by emphasizing functional

equivalence between digital and traditional contracts. The study concludes that harmonized legal

standards and clearer conflict-of-law rules are essential to foster trust in smart contracts and to ensure

legal certainty in global digital markets.
